## 36.1 <u>Permitted Uses</u>

Accessory uses and buildings. Lawfully existing uses and buildings.

### 36.2 Zone Regulations

- (1) The minimum lot area and frontage, the minimum front, side, and rear yard depths, the maximum lot coverage and building height, shall remain as they lawfully existed on the effective date of this By-law.
- (2) The foregoing shall not apply to prevent the enlargement of dwellings and buildings or the erection of buildings accessory thereto subject to compliance with the other regulations contained in this By-law.

## 36.3 Site and Area Specific Regulations

The following site and area specific zones shall be subject to the preceding permitted uses and zone regulations except where those permitted uses and regulations are varied by the provisions of these site and area specific zones.
